Entrance - Program Arrival:

Following sign-in, a staff member will accompany 1 to 3 children at a time to drop off their belongings in their groups' designated area.

Children entering the building must wash their hands for at least 20 seconds with warm water and soap immediately after depositing their belongings.

Each child will be given a daily summary of expected behavior:

- Cough or sneeze into elbow
- No physical contact with other children or staff
- Regular hand washing
- Proper use of toys and equipment
- No sharing of snacks or other items

Children must be able and willing to follow these minimum requirements to participate in our Out-of-School programming.

Program Departure:

Pick-up will take place outside the main doors of the Nelson & District Youth Centre between 4:00pm - 5:30pm.

Please call 250-352-5656 or email youthcentre@nelson.ca to notify of early pick-ups.

- A staff member will meet you outside the designated doors.
- Parents will line up, spacing a minimum of 2 meters from the next family when signing their child out.
- Parents are advised to allow ample time for check-out as it may take longer than usual.

Please Note:

- Any child, parent, staff or visitor must not enter the space if they are sick, even if symptoms resemble a mild cold.
- Anyone returning from any international travel within the last 14 days will not be admitted into the Youth Centre.
- Unwell people waiting for a test or test result for COVID-19 will not be admitted into the Centre.
- Anyone with COVID-19 will not be admitted in the Centre.
- People who have been in close contact with COVID-19 cases during the period of isolation will not be admitted to the Centre.
- Children with mild cold symptoms must stay home until symptoms resolve or for 14 days, whichever is longer.

Each day, children and staff must complete a health assessment questionnaire. Any child, parent, staff or visitor must not enter The Centre if they are sick, even if symptoms resemble a mild cold. Any child who arrives at The Centre with Cold or Flu like symptoms will be sent home immediately.

If a child becomes sick:

- Symptomatic children will immediately be separated from others in a supervised area until they can go home. A staff member will remain with the child at all times.
- The parent or an emergency contact will be notified to pick up the child immediately. If a child presents COVID-19 symptoms, the child will need to be tested for COVID-19 and will not be allowed back to any program until all symptoms subside and a negative test result is provided.
- The area where the symptomatic child was placed will be thoroughly cleaned and sanitized after the child is picked up.
- Children or staff who have been exposed to a person with a confirmed case of COVID-19 will be excluded from the Centre for 14 days.
- If a child or an immediate family member is being investigated through contact tracing, by public health to confirm if they have COVID-19, the Youth Centre will seek direction on how to proceed from Interior Health Authority.
